Birth and Marriage record copies are Certified and cost \$20.00 for the first copy and \$10.00 for each additional copy obtained at the same time.

Death record copies are certified and cost \$24.00 for the first copy and \$14.00 for each additional copy obtained at the same time.

MARRIAGE LICENSE

- 1) The license must be obtained in the County where you are being married.
- 2) You may apply on-line. However, both parties must sign the Application in my office.
- 3) The license is applicable the next day and for the next 60 days.
- 4) Both parties must be at least 18 years of age or have the appropriate signed documents which allows parties to be under that age.
- 5) The fee in Bond County for the license is \$75.00 when done in the Office of the County Clerk.
- 6) FCI Greenville marriage license is \$100.00.
