The bills listed on Edit Report dated April 13, 2022 (see attached) were approved as submitted with a motion made by Wes Pourchot second by Joseph Whalen. Roll Call Vote: 5 ayes, 0 nays, motion carried.

The County Clerk's Report for the month of March 2022 (see attached) was approved as submitted with a motion made by Jacob Rayl second by Wes Pourchot. Roll Call Vote: 5 ayes, 0 nays, motion carried.

Zoning Administrator Brad Criner gave the Board his Mid-April 2022 report which included permits, inspections and revenues (see attached). Roll Call Vote: 4 ayes, 0 nays, motion carried. She has requested to receive five new vehicles that would be at no cost to the county.

Requests to use the Courthouse Grounds from the City of Greenville for June 4th for Dairy Day and the FCI Car Show, June 17th, July 15th and August 12th for Family Fun Friday, September 30th and October 1st for Artwalk and Apple Day, November 26th for the Chamber's Come Home for Christmas which were all approved with a motion made by Joseph Whalen second by Wes Pourchot. Roll Call Vote: 4 ayes, 0 nays, motion carried.

A request to use the Courthouse Lawn for the Bond County Ministerial Alliance for the annual National Day of Prayer event at noon on May 5 (see attached) was approved with a motion made by Jacob Rayl second by Joseph Whalen. Roll Call Vote: 4 ayes, 0 nays, motion carried.

The Board approved the Animal Control Report for the Month of March 2022 (see attached) with a motion made by Wes Pourchot second by Jacob Rayl. Roll Call Vote: 4 ayes, 0 nay, motion carried.

The Board approved the Coroner's Report for the Month of March 2022 (see attached) with a motion made by Joseph Whalen second by Wes Pourchot. Roll Call Vote: 4 ayes, 0 nays, motion carried.

Gerald McCray joined the meeting.

County Clerk Meg Sybert conducted the lottery drawing for County Board terms. The results were: District 1 (4-4-2), District 2 (2-4-4), District 3 (4-4-2), District 4 (2-4-4) and District 5 (4-4-2).

At 7:46 p.m., the Board went into Executive Session with a motion made by Wes Pourchot second by Joseph Whalen. Roll Call Vote: 5 ayes, 0 nays, motion carried.

The Board returned to regular session at 8:02 p.m. with a motion made by Jacob Rayl second by Wes Pourchot. Roll Call Vote: 5 ayes, 0 nays, motion carried.

Board members discussed about salaries for elected officials. After discussion, the Board decided to keep Board District #2 and #4 salary the same, have the Treasurer and County Clerk the same as the Circuit Clerk and Supervisor of Assessments for years 2023-2024 and a \$750 raise for years 2025-2026. This will be prepared in a resolution that will be presented at the next meeting.
