

Proceedings had before the Honorable Board at the regular meeting of said Board, begun and held via Video Conference in the City of Greenville in said County and State, on Tuesday, July 6, 2021, held for the transaction of general County business.

At 9:00 a.m., Chairman, Adam Boudouris, opened the meeting by leading the Pledge of Allegiance. Roll Call showing a quorum present as follows: Adam Boudouris, Jacob Rayl, and Wes Pourchot. Frank Lucco and Gerald McCray were absent.

The minutes of the June 15, 2021, regular meeting was approved as submitted with a motion made by Wes Pourchot second by Jacob Rayl. Roll Call Vote: 3 ayes, 0 nays, motion carried.

The bills listed on Edit Report dated June 16, 2021 and July 1, 2021 (see attached) were approved as submitted with a motion made by Jacob Rayl second by Wes Pourchot. Roll Call Vote: 3 ayes, 0 nays, motion carried.

Zoning Administrator Brad Criner was in attendance to give the Board his June 2021 report which included permits, inspections and revenues (see attached). He also included information about E-permit software company reviews and new information about cell towers.

Under Public Comment, Wes Pourchot wanted to thank the committee and community for hosting a great Fourth Fest.

Gerald McCray joined the meeting via Zoom.

Highway Engineer Jeremy Pestle was in attendance to give updates. He informed the Board that Red Ball Trail bridge construction is still moving forward, he is hoping for construction to potentially start next year. He also informed the Board that oil and chip season is soon and for the county to be aware.

The Board held a discussion about the American Recovery Plan. Treasurer Colleen Camp was in attendance to help clarify what the grant money could be used towards, which included anything that mitigates COVID, revenue loss replacement, support of businesses, infrastructure and premium pay for staff. She informed the Board that we need to have a wish list together and prioritized by July 31st. Discussion was held regarding using ARP grant money for a daycare startup. Colleen indicated that if Greenville is considered a hard-hit economic area, the county could. She will check into that and report back. There was also a concern raised by Adam Boudouris about the use of the churches EIN.

The Board approved a Liquor License for Copper Dock LLC with a motion made by Wes Pourchot second by Jacob Rayl. Roll Call Vote; 4 ayes, 0 nays, motion carried.

The Board announced a Public Hearing for the Downstate Small Business Stabilization Grants for Powhatan and Nuby's Steakhouse on July 20, 2021 at 6:45 p.m.

The Board appointed Adam Boudouris, Nathan Mueller, and Jean Doll to the 377 Board each to a three-year term ending June 30, 2024 with a motion made by Jacob Rayl second by Wes Pourchot. Roll Call Vote: 3 ayes, 0 nays, 1 abstain (Adam Boudouris), motion carried.

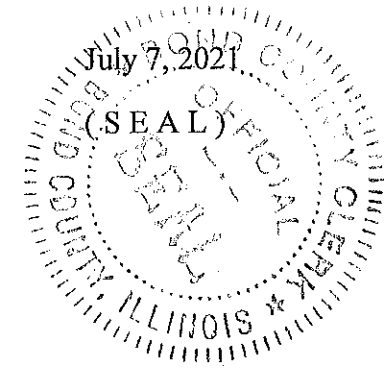

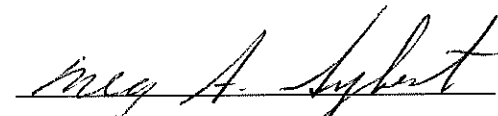
