At 7:00 p.m., Chairman, Adam Boudouris, opened the meeting by leading the Pledge of Allegiance. Roll Call showing a quorum present as follows: Adam Boudouris, Jacob Rayl, Joseph Whalen, Gerald McCray and Wes Pourchot.

The minutes of the July 5, 2022, regular meeting were approved as submitted with a motion made by Jacob Rayl second by Wes Pourchot. Roll Call Vote: 5 ayes, 0 nays, motion carried.

The bills listed on Edit Report dated July 13, 2022 (see attached) were approved as submitted with a motion made by Gerald McCray second by Wes Pourchot. Roll Call Vote: 5 ayes, 0 nays, motion carried.

The County Clerk's Report for the month of June 2022 (see attached) was approved as submitted with a motion made by Joseph Whalen second by Jacob Rayl. Roll Call Vote: 5 ayes, 0 nays, motion carried.

The Board reviewed Zoning Administrator Brad Criner's Mid July 2022 report which included permits, inspections and revenues (see attached). Adam Boudouris informed the Board that the Zoning Board of Appeals monthly meeting for July was canceled due to lack of a quorum and is rescheduled for August 10<sup>th</sup> with Zoom credentials available.

The Board discussed Ordinance 07-19-22-01, a proposed amendment to the Food Service Sanitation Ordinance for Bond County Health Department. Mikayla Flemming from the Bond County Health Department joined the meeting via Zoom to explain that the changes being made are due to an Act that came into effect January 1, 2022. It allows small farms or home bakeries to sell their products directly to customers. If a food born illness would happen to occur, the household could be inspected and the license/ registration can be revoked by the Health Department. After discussion, Ordinance 07-19-22-01 was approved with a motion made by Gerald McCray second by Wes Pourchot. Roll Call Vote: 5 ayes, 0 nays, motion carried.

A request from the Lemuel Rhodes Cancer Foundation to use the Courthouse Lawn for the LRCF Luminary Ceremony on Saturday September 24, 2022 from 3-9 p.m. was presented and approved with a motion made by Jacob Rayl second by Joseph Whalen. Roll Call Vote: 5 ayes, 0 nays, motion carried.

The Board approved the Sheriff's Report for the month of June 2022 (see attached) with a motion made by Joseph Whalen second by Wes Pourchot. Roll Call Vote: 5 ayes, 0 nays, motion carried.

The Board approved the Animal Control Report for the Month of June 2022 (see attached) with a motion made by Gerald McCray second by Jacob Rayl. Roll Call Vote: 5 ayes, 0 nay, motion carried.

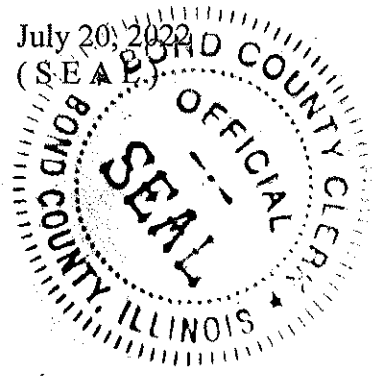
