The minutes of the November 6, 2024 regular meeting were approved as submitted (see attached) with a motion made by Jeff Rehkemper second by Wes Pourchot. Roll Call Vote: 5 ayes, 0 nays, motion carried.

The bills listed on Edit Report dated November 2, 2024 and November 17, 2024 (see attached) were approved as submitted with a motion made by Jacob Rayl second by Chris Timmermann. Roll Call Vote: 5 ayes, 0 nays, motion carried.

The Board approved the County Clerk's Report for October 2024 (see attached) with a motion made by Wes Pourchot second by Chris Timmermann. Roll call Vote: 5 ayes, 0 nays, motion carried.

The Board reviewed Zoning Administrator Brad Criner's Mid-November 2024 report which included permits, inspections and revenues (see attached). The Board reviewed Highway Engineer Mike McCormick's November 2024 report (see attached). Mike was in attendance to give an update on the Red Ball Trail Wooden Bridge Project. The Board discussed the Annual Levy, Budget and Appropriation for the 2024-2025 fiscal year. Jacob Rayl stated that he and Treasurer Colleen Camp have gone over each line item on the Budget and there really isn't anything else that can be reduced as far as expenditures, only salaries. Jacob also pointed out that the Budget that was passed last year was a deficit very similar and we actually ended up in the black this year. Jeff Rehkemper said he feels that we need to have a special meeting with all the department heads to review each budget with each department. Wes Pourchot said the only way to lower the Budget is to start cutting employees or make more revenue. The Board agreed to table until the Special Meeting scheduled for Monday, November 25, 2024 at 2:00 p.m. with a motion made by Jeff Rehkemper second by Chris Timmermann.
