The minutes of the November 18, 2025 regular meeting were approved as submitted with a motion made by Jacob Rayl second by Wes Pourchot. Roll Call Vote: 5 ayes, 0 nays, motion carried.

The bills listed on Edit Reports dated November 26, 2025 and December 2, 2025(see attached) were approved as submitted with a motion made by Jeff Rehkemper second by Wes Pourchot. Roll Call Vote: 5 ayes, 0 nays, motion carried.

During Public Comment, Ron Deedrick raised concerns about the Health Department's financial practices, specifically citing issues with transparency and overspending.

The Board reviewed Zoning Administrator Brad Criner's November 2025 report which included permits, inspections and meeting schedules (see attached).

The Board appointed Bill Walker, Robert Neer, Josh Hill, and Wes Pourchot to the Bond County ETS 911 Board for the term 01/01/2026 -12/31/2029 with a motion made by Jacob Rayl second by Jeff Rehkemper. Roll Call Vote: 4 ayes, 0 nays, Wes Pourchot abstained, motion carried.

The Board appointed Josh Hill to the Greenville Fire District Board of Trustees due to the resignation of Chad Sexton, for the remainder of the 3 year term ending April 30, 2028. with a motion made by Jacob Rayl second by Wes Pourchot. Roll Call Vote: 5 ayes, 0 nays, motion carried.

The Board ratified the approval to allow placement of the Salvation Army Thermometer on the southeast corner of the Courthouse lawn from November 17, 2025, through January 9, 2026. with a motion made by Jeff Rehkemper second by Wes Pourchot. Roll Call Vote: 5 ayes, 0 nays, motion carried.

The Board approved Tax Deed Resolution 12-02-25-01 with a motion made by Wes Pourchot second by Jacob Rayl. Roll Call Vote: 5 ayes, 0 nays, motion carried.

The Board approved Dale Hawkins' request to use the courthouse lawn from 11:00 a.m. to 2:00 p.m. on the following dates: December 7, 14, 21, and 28, 2025. with a motion made by Jacob Rayl second by Bernard Myers. Roll Call Vote: 5 ayes, 0 nays, motion carried

Under Old Business, Jacob Rayl informed the Board that a meeting is scheduled for December 3, 2025, to continue negotiations on the Laborers union contract. Jeff Rehkemper reported that he had passed along the financial information about the Health Department that Ron Dedrick provided to him, and that the matter is currently being reviewed.

Under New Business, Chris Timmermann reported that the boiler in the main courthouse requires repairs. He also noted that the mini split unit in the Probation Department has stopped working. The Board voted to refer both matters to the Public Building Commission. Which will be ratified at the next meeting. Bernard Myers presented a NACO trip to Washington D.C. February 21-24, 2026, stating that if no one else is interested, he would like to attend.
