An opening on the Mulberry Grove Sanitation Board was announced with Julie Nickel seeking reappointment.

Four openings on the Bond County Board of Health were announce with Tracy Hall, Jo Kirkham, Anna Oestreich and Rebecca Nehrt all seeking reappointment.

The Board approved the Sheriff's report for the month of March 2021 (see attached) with a motion made by Gerald McCray second by Jacob Rayl. Roll Call Vote: 5 ayes, 0 nays, motion carried.
