The Board approved the Coroner's June 2025 Report with a motion made by Jacob Rayl second by Jeff Rehkemper . Roll Call Vote: 5 ayes, 0 nays, motion carried.

Under Old Business, Jeff Rehkemper asked how the insurance meeting went. Wes Pourchot stated the committee is still reviewing.

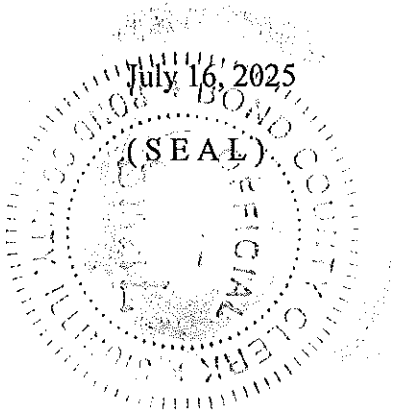
There was no New Business.

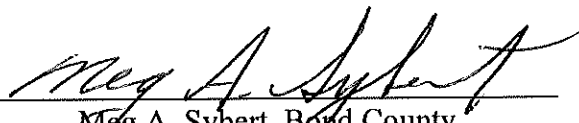
