A Resolution to Commit Funding for Local Daycare Facility (Resolution 07-29-21-01) was approved with a motion made by Gerald McCray second by Jacob Rayl. Kim Taylor from FAYCO has previously presented the Board with a request to purchase a building for holding Day Services to serve the people of Bond County, which was approved with a motion made by Jacob Rayl second by Gerald McCray. Roll Call Vote: 5 ayes, 0 nays, motion carried. County Clerk Meg Sybert presented information for the Land Recording Software program and Permanent Record Scanning, which was approved with a motion made by Wes Pourchot second by Jacob Rayl. Roll Call Vote: 5 ayes, 0 nays, motion carried.
