Hi Chris,

Thanks for taking the time to talk and for your help with this important project.

The Federal Scholarship Tax Credit will go into effect on Jan 1, 2027, as it was already passed into law. Dollar for dollar tax credits will be given to donors residing anywhere in the U.S. up to \$1700.

Each state's Governor must opt-in by submitting to the Treasury department all qualifying Scholarship Granting Organizations (SGOs) in 2026. IF a Governor does not supply that list, money from Illinois donors will go to students in other complying states. Based upon the number of donors in the Invest in Kids program that amount could eclipse \$100M that could go to assist K-12 students attending public, private or home schools in Illinois.

Frankly, all current public education foundations should re-establish themselves as SGO's, offering donors a dollar-for-dollar tax credit, vs a deduction that might not be useful if taking a standardized deduction. Funds then could help pay for ACT testing, tutoring, books, etc in the district.

We are seeking to have the following referendum question placed on the March 17, 2026 ballot as a show to Governor Pritzker that your county supports offering financial support to our students.

Federal Scholarship Tax Credit

Should Illinois opt into a federal program that would provide Public K-12, private school, and homeschool students with privately-donated funds for academic needs, such as tutoring and test preparation, educational therapies for students with disabilities, tuition, books, exam fees or for other specified academic needs?

RESOLUTION TO SUBMIT AN ADVISORY REFERENDUM TO THE VOTERS OF BOND COUNTY REGARDING THE FEDERAL SCHOLARSHIP TAX CREDIT

WHEREAS, Bond County, Illinois is a duly organized and existing county created and operating under the provisions of the Illinois Counties Code and the laws of the State of Illinois; and,

WHEREAS, the Illinois Election Code provides that any public question authorized by statute shall be initiated in accordance with 10 ILCS 5/28-1 and 5/28-5; and,

WHEREAS, Section 5-1005.5 of the Counties Code, 55 ILCS 5/5-1005.5, provides that, by a vote of a majority of the county board, the county board may authorize that an advisory question of public policy be placed on the ballot at the next regularly scheduled election in the county and,

WHEREAS, the Educational Choice for Children Act offers a federal tax credit of up to \$1,700 for individuals that donate to Scholarship Granting Organizations, thereby increasing funding for these organizations to help families pay for their children to attend the K-12 school of their choice; and

WHEREAS, if Illinois opts in, scholarship funds could be used by students in both public and private schools for a multitude of educational services, including tutoring, additional educational classes, books or online educational materials, educational therapies for students with disabilities, fees for standardized or college admission exams and fees for dual enrollment; and,

WHEREAS, donors to scholarships will benefit from tax credits regardless of whether Illinois opts in, but Illinois students will not receive those funds unless the state opts in; and,

WHEREAS, opting into the program would not take money away from public schools, nor would it divert federal money or state money from public schools to fund the scholarships; and,

WHEREAS, the county board of Bond County, Illinois find it to be in the best interests of Bond County, Illinois to put a non-binding, advisory referendum question on the ballot regarding whether the state of Illinois should opt into the scholarship program created by Educational Choice for Children Act, and that said question should be submitted by referendum to the Bond County electorate at the March 17, 2026 general primary election.

NOW THEREFORE, BE IT RESOLVED by the county board of Bond County that the County Clerk is hereby authorized and directed to place on the March 17, 2026, General Primary Election Ballot in Bond County the following non-binding, advisory, public question in accordance with applicable law:

Should Illinois opt into a federal program that would provide Public K-12, private school, and homeschool students with privately-donated funds for academic needs, such as tutoring and test preparation, educational therapies for students with disabilities, tuition, books, exam fees or for other specified academic needs?

Illinois opt-in for federal scholarship tax credit

Problem: In 2023, Illinois joined the minority of states to have no school choice program after ending its private school choice program. Its students are struggling: only 41% of third through eighth graders can read at grade level and just 28% were proficient in math. By 11th grade, not even 1-in-3 can read or do math at grade level. But if Illinois participates in the Federal Scholarship Tax Credit, established by the Educational Choice for Children Act, struggling students and families can obtain privately donated funds, including money from Illinois donors, to use toward educational services.

Solution: To benefit from the tax credit scholarships, Illinois must choose to participate in the program. Doing so would allow the privately donated funds to flow to Illinois students.

Why: Illinois should opt into the scholarship program because:

- Donors to the scholarships will benefit from tax credits regardless of whether Illinois opts in. But Illinois students will not receive those funds unless the state opts in. That means Illinois donations will benefit students in other states, leaving Illinois students behind, unless state leaders join the program.
- If Illinois opts in, scholarship funds could be used by students in both public and private schools for a multitude of educational services, including tutoring, additional educational classes, books or online educational materials, educational therapies for students with disabilities, fees for standardized or college admission exams and fees for dual enrollment.
- Opting in would not take money away from public schools, nor would it divert federal money or state money from public schools to fund the scholarships. The scholarships are funded by private individuals who will be granted federal tax credits for donating up to \$1,700 annually, meaning the cost to the federal government is foregone income tax revenue.

There is no cost to states.
